- 六、隨著疫情持續升溫和防疫政策調整，學生／教師必須關注各國外交部領事局發布的應對 COVID-19 疫情措施清單。若有違規事實，本人將負相關責任。
- 七、本人知悉即使我獲得簽證、因應疫情政策，我也可能被拒絕入境，造成計畫無法完成；本人將自行負擔相關責任。

I hereby declare the above statements to be reliable, and confirm with full legal responsibility for any illegal found.
7. I understand that VISA does not guarantee entry into Taiwan to attend the program, and NTHU is not liable for this.
8. I confirm that I am not joining the program through the Human Resources Agency. The payment, hours, visa, insurance issues definitely obey the local regulations. I understand if there are any inappropriate or illegal occasions, I will lose the qualification of funding and realize the tracking history will be noted in the assessment next year. I am obligated to get the legal visa for the arrangement.
