I) 申請資格 Eligibility

符合以下資格者，得依教育部外國學生來臺就學辦法申請入學。

An individual who meets the following criteria is eligible to apply for admission under “MOEⁱ Regulations Regarding International Students Undertaking Studies in Taiwan.”

- A) 具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者。

An individual of foreign nationality, who has never held Republic of China (“R.O.C.”) citizenship and who does not possess an Overseas Chinese student status at the time of his/her application is eligible to apply.

- B) 具外國國籍且符合下列規定，且最近連續居留海外六年以上者。所定六年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間未逾一百二十日。

An individual of foreign nationality, pursuant to the following requirements i.e., who has resided overseas continuously for no less than 6 years is eligible to apply for admission. The six-year calculation period as prescribed shall be calculated to the starting date of the semester (Feb.1st or Aug.1st). The term “overseas” as prescribed is limited to countries or regions other than Mainland China, Hong Kong and Macau; the term “reside overseas continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year.

- 1) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An individual who is also a citizen of the R.O.C., but does not hold nor has had a household registration in Taiwan is eligible to apply for admission.

- 2) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An individual who was a national of the R.O.C. but had his/her citizenship nullified at the time of his/her application shall have an annulled status for more than 8 years as certified by Ministry of the Interior (MOI).

- 3) 前二款均未曾以僑生身分在臺就學，且未於當學年度經海外聯合招生委員會分發。

Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an Overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.

- C) 具外國國籍，兼具香港、澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者。所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, who has resided in Hong Kong, Macao, or another foreign country continuously for no less than 6 years, is eligible for admission. The term “reside overseas continuously” mentioned in the preceding paragraph means that an individual may have stayed in Taiwan previously for no more than a total of 120 days per calendar year.

- D) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。

An applicant who was a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years, is eligible for admission. The term “reside overseas continuously” means that an individual may have stayed in Taiwan for no more than a total of 120 days per calendar year.

- E) 外國學生具高中畢業資格者，得申請學士班。外國學生具學士學位者，得申請碩士班；具碩士學位者，得申請博士班。

Applicants with a high school diploma are eligible to apply for the four-year undergraduate programs. Applicants with a bachelor's degree are eligible to apply for the master's programs; applicants with a master's degree are eligible to apply for the doctoral programs.

注意事項 Notes

- 1) 以上所稱中華民國國籍係依中華民國國籍法第二條所認定之(如下)。
中華民國國籍法，第二條：有下列各款情形之一者，屬中華民國國籍：
(i) 出生時父或母為中華民國國民。
(ii) 出生於父或母死亡後，其父或母死亡時為中華民國國民。
(iii) 出生於中華民國領域內，父母均無可考，或均無國籍者。
(iv) 歸化者，前項第一款及第二款之規定，於本法修正公布時之未成年人，亦適用之。

R.O.C. nationality mentioned above is defined in accordance with Article 2 of Nationality Law (see below).

According to Article 2 of the Nationality Law, a person shall have the nationality of the R.O.C. under any of the conditions provided by the following subparagraphs:

- (i) His/Her father or mother was a national of the R.O.C. when he/she was born.
(ii) He/She was born after the death of his/her father or mother, and his/her father or mother was a national of the R.O.C. at the time of death.
(iii) He/She was born in the territory of the R.O.C., and his/her parents cannot be ascertained, or both were stateless persons.
(iv) He/She has undergone the nationalization process. Preceding subparagraph 1 and subparagraph 2 shall also apply to the persons who were minors at the time of the revision and promulgation of this Act.
- 2) 外國學生經入學學校以操行不及格或學業成績考核未達規定或因犯刑事案件經判刑確定致遭退學者，不得再依外國學生來臺就學辦法申請入學。

International students who withdraw from university due to behavior issues, poor academic performance or a conviction under the Criminal Code may not thereafter apply again for admission under "MOE Regulation Regarding International Students Undertaking Studies in Taiwan."

- 3) 外國學生申請資格係依據中華民國教育部《外國學生來臺就學辦法》規定。

辦法如經修正，將以教育部公告為準。有關辦法之最新訊息，請洽詢中華民國教育部網頁或全國法規資料庫：<https://reurl.cc/kX0Q5r>。倘若違反教育部規定，經查證屬實者，撤銷其入學資格，開除學籍且不發給任何學歷證明。

The application eligibility is based on "MOE Regulation Regarding International Students Undertaking Studies in Taiwan." If the MOE Regulations are revised, the most updated MOE Regulations shall prevail. For the latest information regarding the MOE Regulations, please visit MOE website or Laws & Regulation Database at <https://reurl.cc/nD0RzI> Violation of the "MOE Regulation" will result in immediate cancellation of the applicant's admission or the deprivation of the applicant's recognized status as NTHU registered student. No academic certificate will be given.

II) 申請流程 Application Procedure

- A) 登入國立清華大學外國學生入學申請線上系統

Go to NTHU International Student Online Application System

B) 設定帳號及密碼 Create Your Account

進入申請線上系統後點選「註冊帳號」，請設定您的帳號(電子郵件帳號)以及密碼。輸入完畢後，請點選「送出」，未完成註冊無法登入系統。本校一律以電子郵件帳號通知申請相關訊息，申請者務必使用有效的電子郵件帳號，以避免因使用錯誤導致無法收到訊息。

Click "Register" to create a Login ID (email account) and password to set up an account. The system will create an account for you after clicking "Submit". You cannot begin applying without first setting up your account. A valid email is required to continue the process, as this will be our primary means of communication with you. If you do not have a valid email account, please create one before proceeding.

C) 填寫線上申請表 Fill Out the Application Information

需填寫的申請資訊分成五個部分，分別是「個人申請資訊」、「家庭資訊」、「教育背景」、「語言能力」及「其他資訊」。於每個部分填寫完後，請先按儲存後，點選下一步到下一個頁面。

The application has five sections, which are "Applicant Information," "Family Information," "Education Background," "Language Background," and "Other Information." When finished with each section, please click "Save" and then "Next" to proceed.

D) 填寫推薦人資訊並寄送推薦信通知 Fill Out Recommenders and Send the Notice

需填寫推薦人資訊，填畢後點選"寄送"以完成推薦信填寫通知。

Fill out your recommenders and click "Send Notice" to proceed.

E) 申請費 Application Fee

For applicants who hold Least Developed Countries (LDCs) nationality are FREE of charge. According to United Nations General Assembly resolutions and regulations set by the United Nations Economic and Social Council, the list of LDCs consists of 44 countries. [Country List Link](#)

繳費方式 Payment Method

1. 國內繳款：填報線上申請表後下載列印繳費單至台灣銀行全省各地分行櫃檯繳費，或持金融卡（請勿使用信用卡）於全省各地自動櫃員機（ATM）辦理轉帳，轉帳衍生相關費用需由繳款人自行負擔。

Domestic (Taiwan) payment: After you have completed the online application form, the system will automatically generate a payment form. Print out the payment form and make the payment to any Bank of Taiwan branch in Taiwan at the counter.

Alternatively, you may pay via bank transfer with the use of a bank card (Do Not Use Credit Card) at any ATM in Taiwan. Any charge for bank transfers shall be borne by the applicant.

2. 線上信用卡繳款：於線上刷卡完成繳款作業後，下載「線上刷卡繳費證明」。
Online Credit Card Payment: Please pay through the online credit card payment system. Then, download the “payment invoice”. Click “payment record” and make screenshot as the payment invoice.

注意事項 Notes

- 1) 未收到申請費之申請件，將不予受理。
Applications with unpaid application fees will not be processed.
- 2) 國內繳款限以新臺幣計；不接受其他幣值，且不接受郵寄現金或支票。
Domestic (Taiwan) payments are only accepted in NT dollars. Other currencies and cash sent by post and/or in bank notes will not be accepted.
- 3) 申請費一經繳交，恕不退還，包含申請未完成、放棄申請、申請資格不符、逾期送件、溢繳、重複繳費、誤繳等。
The application fee is non-refundable under any circumstances, including cases of incomplete applications, cancelled applications, ineligible applications, late applications, overpayment, double payment, mistaken payment and etc.

F) 上傳申請文件 Upload Requirements

依規定上傳申請文件

Prepare materials required for uploading. The applicant must upload all application requirements.

G) 確認後送出申請資料 Confirm and Submit Your Application

確認上傳資料後點選「送出」以完成申請程序。雖已於報名登錄期限前上網登錄報名表及繳費者，但未於繳件期限日內完成上傳申請資料，視同放棄報名。

The applicant must confirm and click "Submit" to complete the application. Applicants who complete the online application and payment but fail to upload all required documents by the application deadline will be considered to have withdrawn their application.

III) 申請文件 Required Documents

A) 申請費收據 Application fee Payment Receipt

請務必將申請費繳費收據(轉帳明細表或刷卡繳費證明)上傳至線上申請系統。並於申請費繳費收據上註明申請編號。若申請二系所以上，需將所有申請編號登錄於收據。請見範例一及範例二。

Be sure to upload the application fee payment receipt (either transaction receipt or payment record screenshot) onto the online application system after you have made the payment. Please specify your application number on the receipt. If you are applying for more than one program, please include all applications numbers on the receipt. See example one and two.

B) 線上入學申請表 The online application form

請至本校「外國學生線上系統」填寫入學申請資料。

The applicant must complete the application form through the NTHU's online application system.

C) 畢業證書影本一份 / One copy of your diploma

畢業證書須為中文或英文，中、英文以外之語文，除須提供原文正本，另須檢附正式翻譯的英文或中文譯本。申請者如是應屆畢業生，請提交校方出具之應屆畢業證明。欲申請第二個

同等學位者，請同時提交第一學位的畢業證書影本。若持大陸地區學士學位以上者，需另繳交學位證明書。 ■ 申請學士班：高中畢業證書 ■ 申請碩士班：大學畢業證書 ■ 申請博士班：碩士畢業證書。 註：核定錄取後須另檢附經公證之中文或英文譯本。

NTHU only accepts diplomas written in English or Chinese. Thus, if your diploma were written in other languages, it should be accompanied by an official English or Chinese translated version. Applicants who are in the process of completing studies must submit a certificate of expected graduation from the school clearly stating the anticipated credit obtained, graduation date, and degree. Applicants who will be pursuing a second degree in a different field of study must also submit a photocopy of the first degree/diploma. Applicants, who received a bachelor degree or above from schools in Mainland China, are required to additionally provide certificate of degree conferral. ■ Applicants for Bachelor programs: high school diploma ■ Applicants for Master programs: bachelor degree's diploma ■ Applicants for the Ph.D. programs: master degree's diploma. Note: The notarized English or Chinese diplomas will be required after an acceptance of admission.

D) 成績單影本一份 / One copy of your official transcript(s)

成績單(中文或英文)須有申請人姓名、就讀系所(專業)、在校每學期修讀課程成績、入學及畢業時間，並附上成績評分標準對照表。如成績單 為中、英文以外之語文，除須提供原文正本，另須檢附正式翻譯之中文或英文譯本。 ■ 申請學士班：高中歷年成績單 ■ 申請碩士班：大學歷年成績單 ■ 申請博士班：碩士歷年成績單。註：核定錄取後須另檢附經公證之中文或英文譯本。

Academic transcript (in Chinese or English) must include the applicant's name, department/major, grades for all courses taken each semester during enrollment, and the dates of admission and graduation. A grading scale/conversion table must also be attached. If it is not in Chinese or in English, it should be accompanied by an official English or Chinese translated version. In addition, the grading system must also be included. ■ Applicants for Bachelor programs: transcripts of the high school ■ Applicants for Master programs: transcripts of the bachelor degree ■ Applicants for the Ph.D. programs: transcripts of the master degree. Note: The notarized English or Chinese transcript will be required after an acceptance of admission.

註：一、持高級中等學校學歷者，累計修業時間應符合當地國學制之規定。二、持學士學位者，累計修業時間至少須滿三十二個月。三、持碩士學位者，累計修業時間至少須滿八個月。

1. An applicant who has senior secondary school academic credential shall have spent a total period undertaking the senior secondary program that satisfies the regulations of the education system in the country where the school they attended is located. 2. An applicant who has a bachelor's degree shall have spent a total period of at least 32 full months undertaking the bachelor's degree program. 3. An applicant who has a master's degree shall have spent a total period of at least eight full months undertaking the master's degree program.

E) 讀書計畫一份 One copy of statement of purpose

■學士班：請參考讀書計畫檔案以中文或英文撰寫。 ■碩士班、博士班：於這份讀書計畫中，請簡要寫出一篇至多三頁的說明，內容建議包括選擇 本校、學系、學程的動機。

■Bachelor Applicants: Please download the "statement of purpose instructions for international applicants" and you may write in Chinese or English. ■Master/Ph. D. Applicants: Please write a brief statement of purpose with minimum of one page and no more than three pages. In the statement of purpose, applicants are encouraged to provide their motivation for choosing NTHU and the specific department/program.

F) 推薦信兩封 Two recommendation letters

請於線上系統填寫兩位推薦人資料，建議推薦者為能評量申請者學術能力及研究潛力的師

長為優先。填畢推薦人資訊後，務必點擊“寄出通知”，推薦人才能收到系統寄發的推薦信填寫通知。請自行確認推薦人於申請期限內完成線上推薦信上傳或填寫，否則無法送出申請件。

Complete the information for two recommenders on the online application system. Preferably, recommenders are teachers who can evaluate your academic qualifications and research potential. Fill out your recommenders and click "Send Notice" to proceed. Please ensure that your recommenders complete your recommendations before the application deadline or you can not submit your application.

G) 財力證明 Financial Statement

申請者需提供足夠在臺就學之存款證明(新臺幣12萬元或4千美金)或已獲獎獎學金證明，以上皆須為英文或者中文。存款證明須為最近3個月由金融機構核發，請註明幣值及匯率(如幣值非美金或台幣)並換算為新台幣或美金的總額。如存款證明非申請者帳戶，需檢附財力切結書並敘明兩者關係。資助者僅限提供個人帳戶資料，不接受公司帳戶。另外，國立清華大學國際學生獎學金申請表不能作為財力證明。財力證明請見範例。

All applicants are required to provide either an official bank final balance statement (NTD 120,000 or USD 4,000) or proof of granted scholarship that shows their financial sustainability for study in Taiwan. All documents must be written in English or Chinese. The bank final balance statement(s) should be dated within the last 3 months from a financial institution. If the currency is not in NTD or USD, please note the exchange rate and conversion of the total amount in NTD or USD. If the bank account is from their sponsor to satisfy this financial obligation, then their sponsor must sign the [Certification of Financial Responsibility Form] and declaring the relationship to the applicant. For sponsor's account, we only accept personal account. We do not accept corporate account. More, NTHU International Student Scholarship application form cannot be used as a financial statement. See example here.

H) 財力切結書 Certification of Financial Responsibility Form

財力切結書填寫財力來源，若財力來源非申請者，請填寫與申請者關係與資訊。

On the form, applicants must state the source of the money relates to the Financial Statement. If the bank account is from their sponsor to satisfy this financial obligation, then their sponsor must provide a statement declaring your relationship to the applicant and their intent to provide financial support throughout their period of study. Select “personal funds” if the name of the bank statement is same as the applicant. Select “sponsor” if the name of the bank statement is different than the applicant.

I) 具結書 Declaration Form

請於線上系統列印並詳讀具結書後簽署。本校視個案情況得要求申請者檢附由內政部核發的「喪失國籍許可證明書」影本及「入出國日期證明書」，並簽署未設戶籍證明書等文件。範例。

Print the declaration form (generated by the online application system) and after reviewing the form, please print and sign at the bottom of the form. If applicable, we may ask the applicant to submit a copy of the “Forfeited Nationality Permit Certificate,” “Certificate of Entry and Exit Dates” issued by MOI and a signed “Non-Household Registration Declaration.” See example here.

J) 國籍證明文件 Verification of Nationality

申請者須繳交國籍證明文件或護照影本。若持有居留證，請一併提供。

Provide verification of your nationality or a copy of your passport. Please also provide Alien Resident Certificate (if any).

K) 國立清華大學之入學語言門檻

National Tsing Hua University's Minimal Language Requirements if the department has higher standard, please refer to the requirement of the department.

i. 英語能力證明可繳交以下任一，若科系有額外要求則以系所為準：

Proof of English Proficiency (fulfilling ONE of the followings):

1. 英語能力測驗達 CEFR B2 等級以上
Certificate of CEFR B2 level or above.
TOEFL iBT 4.0 Scale: 4.0 (Legacy TOEFL iBT score minimum: 71; TOEFL Home Edition and TOEFL ITP are not accepted.)
TOEIC(Public Testing Programme): 750
IELTS (Academic): 5.5
2. 英語系國籍者，提供國籍證明文件(註.菲律賓、紐西蘭、澳洲皆歸類為英語系國家，印度不歸類為英語系國家) 國家認定連結。
If you are from an English-speaking country, provide Nationality Document. (Note. Philippine, Australia, and New Zealand are included as English-speaking country, India is not included.) [Country List Link](#)
3. 前一學位為全英語授課，提供學校開立證明。
If your previous degree is fully taught in English, provide an official statement
4. 前一學位為英語文相關科系，提供畢業證書。
If your previous degree is English Language related degree, provide diploma

ii. 華語能力證明可繳交以下任一：

Proof of Mandarin Proficiency (fulfilling ONE of the followings):

1. 華語文能力測驗或其他同等級檢定，達華語文能力測驗：基礎級二級(TOCFL A2) 或新漢語水平考試：四級(HSK L4) 以上。
Test of Chinese as a Foreign Language TOCFL A2 level or HSK L4 or above, or other official credentials for equivalent Chinese language competency.
2. 國籍為華語系國家(例如:新加坡)
If you are from a Chinese-Speaking Country, provide Nationality Document. (Ex. Singapore)
3. 前一學位為中文授課，提供學校開立證明。若前一學歷為中國的學校畢業，提供畢業證書。
Your previous degree is fully taught in Chinese, provide an official statement. If your previous degree is obtained in China, provide degree diploma.
4. 前一學位為中文語文相關科系，提供畢業證書。
If your previous degree is Chinese Language related programs, provide degree diploma.

iii. 依系所授課語言不同而需繳交不同的語言能力證明，例如中國文學系為全中文授課，則只須繳交華語能力證明，不需繳交英語能力證明。

The minimal language requirements are set according to the language taught by the program. For example, programs offered by “Department of Chinese Literature” are fully taught in Chinese, the applicants are only required to provide “proof of Mandarin Proficiency”. No need to provide “proof of English Proficiency”.

Applicants who received a bachelor's degree or above from schools in Mainland China, are required to provide:

- (1) graduation certificate
- (2) degree certificate
- (3) full transcripts
- (4) the verification reports of the above documents from the designated verification center.
- (5) Those with a master's degree or above should also submit the dissertation.

Further information please follow the regulations regarding the assessment and recognition of credentials from Mainland China.

教育部 外國學生來臺就學辦法

第 1 條

本辦法依大學法第二十五條第三項、專科學校法第三十二條第一項、高級中等教育法第四十一條第一項及國民教育法第六條第三項規定訂定之。

第 2 條

1. 具外國國籍且未曾具有中華民國國籍，符合下列規定者，得依本辦法規定申請入學：
 - 一、未曾以僑生身分在臺就學。
 - 二、未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。
2. 具外國國籍並符合下列規定，且最近連續居留海外六年以上者，亦得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上：
 - 一、申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。
 - 二、申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。
 - 三、前二款均應符合前項第一款及第二款規定。
3. 依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管機關核准，得不受前二項規定之限制。
4. 第二項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。
5. 第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：
 - 一、就讀僑務主管機關舉辦之海外青年技術訓練班或教育部（以下簡稱本部）認定之技術訓練專班。
 - 二、就讀本部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。
 - 三、交換學生，其交換期間合計未滿二年。
 - 四、經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。
6. 具外國國籍並兼具中華民國國籍，且於本辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。具有國籍法第二條規定情形者，為本辦法所定具有中華民國國籍。

第 3 條

1. 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外

連續居留滿六年以上者，得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上。

2. 前項所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入前項連續居留期間計算。
3. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者，其連續居留年限為八年以上。
4. 前項所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外連續居留期間計算。
5. 第一項及第三項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。
6. 第一項至第四項所定海外，準用前條第五項規定。

第 4 條

1. 外國學生依前二條規定申請來臺就學，以一次為限；其繼續在臺就學者，入學方式應與我國內一般學生相同。外國學生有下列情形之一者，其於前項申請後，復申請繼續在臺就學，或再次申請來臺就學，不受前項規定之限制：
 - 一、於完成申請就學學校學程後，申請碩士班以上學程，逕依各校規定辦理。
 - 二、外國學生申請來臺就讀學士班以下學程，在國內停留未滿一年，因故退學或喪失學籍，得重新申請來臺就學，並以一次為限。
 - 三、符合第二條第一項規定之外國學生，申請就讀副學士以下學程。
 - 四、符合第二條第一項規定之外國學生，申請入學大學醫學、牙醫或中醫學系以外之學士班學程並以一次為限。
2. 外國學生經入學學校以操行不及格或學業考核未達規定、違反法令或校規情節嚴重致遭退學或喪失學籍者，不得再依前二項規定申請入學。

第 5 條

1. 大學及專科學校二年制（以下簡稱大專校院）實際招收入學之外國學生，其名額以本部核定該校前一學年度招生名額外加百分之十為原則，並應併入當學年度招生總名額報本部核定；申請招收外國學生名額超過前一學年度核定招生名額外加百分之十者，應併同提出增量計畫（包括品質控管策略及配套措施）報本部核定。但國內大學與外國大學合作並經本部專案核定之學位專班，不在此限。
2. 專科學校五年制及高級中等以下學校實際招收入學之外國學生，其名額以各主管機關核定該校前一學年度招生名額外加百分之十為限，並應併入當學年度招生總名額報各主管機關核定。
3. 大專校院於前一學年度核定招生總名額內，有本國學生未招足情形者，得以外國學生名額補足，

並應報本部核定。

4. 第一項及第二項招生名額，不包括未具正式學籍之外國學生。

第 6 條

1. 大專校院招收外國學生入學各年級，應擬訂公開招生規定報本部核定，其內容應包括招生方式、入學資格審查程序、學系(程)授課語言、學生應具備之語文能力基準、財力證明基準及其他相關事項。
2. 前項招生規定經本部核定後，大專校院應自行訂定外國學生招生簡章，詳列招生方式、入學資格審查程序、招生學系(程)、各學系(程)授課語言、學生應具備之語文能力基準、修業年限、招生名額、申請資格、財力證明基準、學雜費收退費基準、學校獎助學金資訊及其他相關事項。
3. 大專校院辦理外國學生招生事務，除宣傳推廣及協助學生辦理來臺相關必要程序外，不得委由校外機構、法人、團體或個人辦理；並應適時確認其是否向外國學生收取不合理之費用、成立借貸關係或其他違反相關法令之情形，必要時得向申請之外國學生查核。
4. 大專校院自行或委由校外機構、法人、團體或個人辦理外國學生招生相關事項，不得提供與招生規定、招生簡章或相關規定不一致之資訊。

第 7 條

1. 申請入學大專校院之外國學生，應於各校院指定期間，檢附下列文件，逕向各該校院申請入學，經審查或甄試合格者，發給入學許可：
 - 一、入學申請表。
 - 二、學歷證明文件：
 - (一)大陸地區學歷：應依大陸地區學歷採認辦法規定辦理。
 - (二)香港或澳門學歷：應依香港澳門學歷檢覈及採認辦法規定辦理。
 - (三)其他地區學歷：
 - 1.海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。
 - 2.前二目以外之國外地區學歷，應依大學辦理國外學歷採認辦法規定辦理。但設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。
 - 三、足夠在臺就學之財力證明，或政府、大專校院或民間機構提供全額獎助學金之證明。
 - 四、申請學校所規定之其他文件。
2. 各校審核外國學生之入學申請時，對前項第二款至第四款未經我國駐外機構、行政院設立或指定之機構或委託之民間團體驗證之文件認定有疑義時，得要求經驗證；其業經驗證者，得請求協助查證。
3. 第一項入學許可應載明外國學生之姓名、就讀學程名稱、學位別、授課語言、入學之學年、學期開始日期、學雜費收退費基準、獎助學金及其他應告知外國學生之相關資訊之中文及英文版本，確認外國學生瞭解來臺就學相關權利義務，並得提供外國學生母國語言版本。

第 7-1 條

外國學生所繳入學證明文件有偽造、假借、塗改等情事，應撤銷錄取資格；已註冊入學者，撤銷其學籍，且不發給任何相關學業證明；如畢業後始發現者，應由學校撤銷其畢業資格並註銷其學位證書。

第 8 條

1. 外國學生已在臺完成學士以上學位，繼續申請入學碩士以上學程者，得檢具我國各校院畢業證書及歷年成績證明文件，依第七條規定申請入學，免檢附第七條第一項第二款規定之境外學歷證明文件。
2. 符合第二條第一項規定之外國學生，在我國完成副學士以下學程者，得持該學歷證明文件及歷年成績證明文件，依第七條、第十八條、第二十條規定申請入學學士班以下學程，免檢附第七條第一項第二款、第十八條第一項第二款及第二十條第一項第三款規定之境外學歷證明文件。

第 9 條

招收外國學生之大專校院，應即時於本部指定之外國學生資料管理資訊系統，登錄外國學生錄取、入學、轉學、休學、退學或變更、喪失學生身分、離境等情事。

第 10 條

外國學生不得申請就讀我國大專校院所辦理回流教育之進修學士班、碩士在職專班及其他僅於夜間、例假日授課之班別。但外國學生在臺已具有合法居留身分者或其就讀之班別屬經本部專案核准之課程者，不在此限。

第 11 條

大專校院、專科學校五年制、高級中等以下學校之外國學生註冊入學時，未逾該學年第一學期修業期間三分之一者，於當學期入學；已逾該學年第一學期修業期間三分之一者，於第二學期或下一學年註冊入學。但各主管機關另有規定者，不在此限。

第 12 條

1. 大學外國學生於我國大學畢業後，經學校核轉本部許可在我國實習者，其外國學生身分最長得延長至畢業後一年。
2. 外國學生來臺就學後，其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，喪失外國學生身分，應予退學。但符合下列情形之一者，不在此限：
 - 一、入學方式與我國內一般學生相同者，
 - 二、依國籍法第四條第一項第一款至第三款申請歸化取得中華民國國籍者
 - 三、符合第二條第一項規定且依國籍法第三條至第七條申請歸化取得中華民國國籍。
3. 於我國大專校院就讀之外國學生轉學，由各大專校院自行訂定相關規定，並納入招生規定報本部核定。但外國學生經入學學校以操行不及格或因刑事案件經判刑確定致遭退學者，不得轉學進入大專校院就讀。

第 13 條

1. 大專校院在不影響正常教學情況下，得與外國學校簽訂教育合作協議，招收外國交換學生；並得準用外國學生入學規定，酌收外國人士為選讀生。
2. 高級中等以下學校經各主管機關核准者，得招收外國學生來臺進行一年以下之短期研習。

第 14 條

各級學校因國際學術合作計畫或其他特殊需求成立外國學生專班者，應依各級學校總量發展規模與資源條件相關規定，經該管主管機關核轉本部核定。

第 15 條

1. 本部為獎勵就讀大專校院優秀外國學生，得設置或補助學校設置外國學生獎學金。
2. 大專校院為鼓勵外國學生來臺就學，得自行提撥經費設置外國學生獎學金、助學金。

第 16 條

1. 大專校院應指定專責單位或人員負責辦理外國學生就學申請、輔導、聯繫等事項，並加強安排住宿家庭及輔導外國學生學習我國語文、文化等，以增進外國學生對我國之了解。
2. 大專校院應於每學年度不定期舉辦外國學生輔導活動或促進校園國際化，有助我國學生與外國學生交流、互動之活動。

第 17 條

1. 專科學校五年制及高級中等以下學校招收外國學生，除依第二十條規定辦理在臺已具有合法居留身分之外國學生申請入學外，應擬訂招收外國學生來臺就學有關計畫，於每年十一月三十日前報該管主管機關核定後，始得招生。直轄市、縣（市）主管機關並應於每年十二月三十一日前，將核定招生學校名冊報本部備查。
2. 前項計畫內容應包括專責外國學生單位之設置、加強我國語文、文化學習課程之規畫及安排外國學生住宿之措施等事項。
3. 第一項學校招收外國學生之國別及名額，必要時得由本部會商內政部及外交部後定之。

第 18 條

1. 申請入學專科學校五年制及高級中等以下學校之外國學生，除第二十條另有規定外，應於各校指定期間，檢附下列文件，逕向各校申請入學，經審查或甄試合格者，發給入學許可：
 - 一、入學申請表。
 - 二、學歷證明文件：
 - （一）大陸地區學歷：應依大陸地區學歷採認辦法規定辦理。
 - （二）香港及澳門學歷：應依香港澳門學歷檢覈及採認辦法規定辦理。
 - （三）其他地區學歷：

1.海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

2.前二目以外之國外地區學歷，應依本部國外學歷查證認定相關規定辦理。設校或分校於大陸地區之國外學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

三、足夠在臺就學之財力證明。

四、在臺監護人資格證明文件。

五、經駐外機構驗證之父母或其他法定代理人委託在臺監護人之委託書。

六、經我國公證人公證之在臺監護人同意書。

七、申請學校所規定之其他文件。

2. 前項第二款學歷證明文件，於申請入學國民小學一年級上學期者，免予檢附。

3. 第一項第四款至第六款文件，外國學生已成年者，免予檢附。

4. 各校審核外國學生之入學申請時，對第一項第二款、第三款及第七款未經駐外機構、行政院設立或指定之機構或委託之民間團體驗證之文件認定有疑義時，得要求驗證；其業經驗證者，得請求協助查證。

第 19 條

1. 前條所稱在臺監護人，應為在臺設有戶籍之中華民國國民，並提出無犯罪之警察刑事紀錄證明及稅捐機關核發最新年度個人各類所得總額新臺幣九十萬元以上之資料清單。

2. 符合前項規定者，每人以擔任一位外國學生之在臺監護人為限。但以校長、學校財團法人董事長或董事為監護人者，每人以擔任五位外國學生之在臺監護人為限。

第 20 條

1. 在臺已有合法居留身分，申請入學專科學校五年制及高級中等以下學校之外國學生，應檢具下列文件，逕向學校申請，並經甄試核准後註冊入學：

一、入學申請表。

二、合法居留證件影本。

三、學歷證明文件：

(一) 大陸地區學歷：應依大陸地區學歷採認辦法規定辦理。

(二) 香港及澳門學歷：應依香港澳門學歷檢覈及採認辦法規定辦理。

(三) 其他地區學歷：

1.海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

2.前二目以外之國外地區學歷，應依本部國外學歷查證認定相關規定辦理。設校或分校於大陸地區之國外學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

2. 前項第三款學歷證明文件，於申請入學國民小學一年級上學期者，免予檢附。

3. 各校審核外國學生之入學申請時，對第一項第三款未經駐外機構、行政院設立或指定之機構或委

託之民間團體驗證之文件認定有疑義時，得要求驗證；其業經驗證者，得請求協助查證。

4. 高級中等以下學校應於第一項外國學生註冊入學後，列冊報該管主管機關備查。
5. 第一項外國學生如申請高級中等以下學校因招生額滿無法接受入學，得向主管機關申請輔導至有缺額之學校入學。
6. 高級中等以下學校得視第一項申請入學學生甄試成績，編入適當年級就讀或隨班附讀；附讀以一年為限，經考試及格者，承認其學籍。

第 20-1 條

1. 外國學生因該國發生戰亂、重大災害或重大傳染疾病疫情等情事，致該地區之學校無法正常運作，得經我駐外機構、或其本國駐華使領館或授權機構檢齊相關評估資料，經本部會同外交部、內政部移民署等相關機關認定後，其入學高級中等學校、專科學校以專案辦理招生。
2. 前項專案就學採外加名額者，以各校招生核定各該學制總名額外加百分之一為原則。

第 21 條

1. 外國學生就學應繳之費用，依下列規定辦理：
 - 一、依前二條規定入學者、經駐外機構推薦來臺就學之外交部臺灣獎學金受獎學生及具我國永久居留身分者，依就讀學校所定我國學生收費基準辦理。
 - 二、依教育合作協議入學者，依協議規定辦理。
 - 三、前二款以外之外國學生，依其就讀學校所定外國學生收費基準，並不得低於同級私立學校收費基準。
2. 本辦法中華民國一百年二月一日修正施行前已入學之學生，該教育階段應繳之費用，仍依原規定辦理。

第 22 條

1. 外國學生註冊時，新生應檢附已投保自入境當日起至少六個月效期之醫療及傷害保險，在校生應檢附我國全民健康保險等相關保險證明文件。
2. 前項保險證明如為國外所核發者，應經駐外機構驗證。

第 23 條

外國學生有違反就業服務法之規定經查證屬實者，學校或相關主管機關應即依規定處理。

第 24 條

外國學生有休學、退學或變更、喪失學生身分等情事，學校應通報外交部領事事務局及學校所在地之內政部移民署各服務站，並副知本部。

第 25 條

1. 學校違反本辦法規定者，主管機關依相關法令規定處理。

2. 學校未依第二十三條規定處理者，各該主管機關並得視情形調整招收外國學生名額。

第 26 條

外國學生來臺於大專校院附設之華語文中心學習語文者，其申請程序、獎補助、管理與輔導、缺課時數逾該期上課總時數四分之一以上及變更或喪失學生身分之通報，準用第七條第一項第一款、第三款、第四款、第九條、第十五條、第十六條、第二十二條及第二十四條規定。

第 27 條

第七條第一項第一款、第十八條第一項第一款及第二十條第一項第一款所定書表格式，由各校定之；第十八條第一項第五款及第六款所定書表格式，由本部定之。

第 27 -1 條

1. 實驗教育機構得依高級中等以下教育階段非學校型態實驗教育實施條例，並準用本辦法規定，招收外國學生來臺就學；其準用本辦法之範圍如下：

- 一、第二條。
- 二、第三條。
- 三、第四條。
- 四、第十一條。
- 五、第十三條第二項。
- 六、第十七條第一項。
- 七、第十八條。
- 八、第十九條第一項。
- 九、第二十條第一項至第四項。
- 十、第二十二條。
- 十一、第二十三條。
- 十二、第二十五條第一項。
- 十三、前條。

2. 實驗教育機構擬訂外國學生來臺就學有關計畫之內容，應包括外國學生專責人員之設置等事項。
3. 實驗教育機構招收外國學生之國別，比照高級中等以下學校招收外國學生之國別規定。
4. 符合第十九條第一項所定資格者，每人以擔任一位外國學生之在臺監護人為限。但實驗教育機構之負責人或設立實驗教育機構之非營利法人代表，每人以擔任五位外國學生之在臺監護人為限。
5. 實驗教育機構招收外國學生之收、退費相關規定，應納入高級中等以下教育階段非學校型態實驗教育實施條例第六條第四項第七款收、退費規定。
6. 外國學生有喪失學生身分、休學、變更或終止短期研習及其他情事，實驗教育機構應通報外交部領事事務局及學校所在地之內政部移民署各服務站，並副知本部、直轄市、縣（市）主管機關及設籍學校。

第 28 條

1. 本辦法自中華民國一百零一年八月一日施行。
2. 本辦法修正條文，除中華民國一百零一年十二月二十四日修正發布之條文，自一百零二年一月一日施行，一百零二年八月二十三日修正發布之條文，自一百零二年九月一日施行外，自發布日施行。

MOE “Regulations Regarding International Students Undertaking Studies in Taiwan”

Article 1

These Regulations are formulated in accordance with the provisions of Article 25, Paragraph 3 of the University Act, Article 32, Paragraph 1 of the Junior College Act, Article 41, Paragraph 1 of the Senior High School Education Act, and Article 6, Paragraph 3 of the Primary and Junior High School Act.

Article 2

A person of foreign nationality who has never held Republic of China (“R.O.C.”) nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations:

1. The person has never undertaken studies in Taiwan as an overseas Chinese student.
2. The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years is also permitted to apply for admission to an educational institution, in accordance with these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

1. A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.
2. A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application.
3. A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval.

The periods of six years and eight years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

The term “overseas” used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term “reside overseas continuously” means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

1. attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;
2. spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;
3. spent a total period of less than two years in Taiwan as an exchange student; or
4. spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.

A person who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011 amendment to these Regulations may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2.

In these Regulations a person to whom any of the circumstances set out in Article 2 of the Nationality Act apply is deemed to have Republic of China (“R.O.C.”) nationality.

Article 3

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years. The term “resided [...] continuously” in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period of continuous residence referred to in the previous paragraph.

A person who was formerly from the Mainland Area and who has foreign nationality and has never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution, in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

The term “resided [...] continuously” in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period that they resided continuously overseas referred to in the previous paragraph.

The periods of six years and eight years stipulated in Paragraph 1 and in Paragraph 3 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

The definition of “overseas” given in Paragraph 5 of the previous article also applies, *mutatis mutandis*, to Paragraphs 1 to 4.

Article 4

An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is limited to only applying once. If a student wants to continue studying in Taiwan, their application shall be handled in the same manner as the admission procedures for domestic students.

An international student in any of the following circumstances, who after applying to study in Taiwan in accordance with the preceding paragraph, is applying to continue studying in Taiwan, or is once again applying to study in Taiwan, is not subject to the restriction set out in the preceding paragraph.

1. If the international student is applying for admission to a master’s degree or higher-level program after completing the course of study at the educational institution to which they originally applied. The university to which the student is now applying shall handle the application in accordance with its regulations;

2. If the international student applied to come to Taiwan to undertake a bachelor's degree or lower-level program in Taiwan and after coming to Taiwan stayed for less than one year for some reason then discontinued their studies or forfeited their student status, that student may lodge another application to come to Taiwan to study, but only one such further application is permitted.

3. If the international student meets the requirements set out in the provisions of Article 2, Paragraph 1 and they are applying for admission to an associate degree program or a program below that level.

4. If the international student meets the requirements set out in the provisions of Article 2, Paragraph 1 and they are applying for admission to a bachelor’s degree program other than one in a university department of medicine, dentistry, or Chinese medicine; only one such further application is permitted.

If an educational institution in Taiwan where an international student was studying considers that their conduct or academic performance was unsatisfactory, or if the student seriously violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of its regulations governing student awards and penalties had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan on the basis of the provisions of the previous two paragraphs.

Article 5

In principle, the actual number of places available for international students to be admitted to universities and two-year programs at junior colleges (hereunder referred to as “universities and tertiary colleges”) is limited to an additional ten percent above the admission quota that was approved for the institution for the previous academic year by the Ministry of Education, and that number shall be incorporated into the total admission quota and reported to the Ministry of Education for approval. A university or junior college applying to recruit more than an additional ten percent shall submit a report of the planned increment (including associated quality control strategy and supportive measures) to the Ministry of Education for approval. Degree programs offered by collaborating domestic and foreign universities that have been approved on a case by case basis by the Ministry of Education are not subject to this restriction.

The actual number of international students that may be admitted to a five-year program at a junior college, or to a senior secondary school, junior high school, or an elementary school is limited up to an additional ten percent above the admission quota that was approved for the institution for the previous academic year that was approved by the competent education administrative authority, and that number shall be included in the total number of students admitted for that academic year and be reported to the competent education administrative authority for approval.

Universities and tertiary colleges may augment the number of places at their institution available to international students by the number of places that were available to local students within the admission quota that was approved for the institution for the previous academic year and shall first report such an increase to the Ministry of Education for approval.

The admission quotas referred to in Paragraph 1 and Paragraph 2 do not include international students who are not officially registered as a current student.

Article 6

A university or tertiary college that recruits and admits international students into any year of its programs shall draw up its own related admission regulations to be made public and submit them to the Ministry of Education for approval. The contents shall include its recruitment method(s), admission eligibility review procedure, teaching language(s) used by departments (programs), student language proficiency criteria, proof of financial resources criteria, and other related matters.

After the admission regulations referred to in the preceding paragraph have been approved by the Ministry of Education, each university or tertiary college shall formulate its own admission guidelines for international students that give details of its recruitment method(s), admission eligibility review procedure, the departments (programs) that may admit international students, teaching language(s) used by each of those departments (programs), student language proficiency criteria, the maximum number of years in which each program must be completed, admission quotas, eligibility criteria to apply for admission, proof of financial resources criteria, tuition and miscellaneous fee collection and refund criteria, information about scholarships and/or grants provided by the educational institution, and other related matters.

Universities and tertiary colleges that handle the recruitment of international students are not permitted to commission any external institution, legal person, group, or individual to handle related matters except publicity and promotion, and to assist students coming to Taiwan undertake the necessary related procedures. In due course each university and tertiary college shall also verify whether any commissioned party has collected any unreasonable fees from international students, established any loan relationship with any international student, or whether any other violation of related ordinances has occurred, and when necessary, it may check details with international student(s) who are applying for admission.

When a university or tertiary college handles matters related to the admission of international students itself or it commissions an external institution, legal person, group, or individual to do so, it is not permitted to provide any information that is inconsistent with its admission regulations, admission guidelines, or any related regulations.

Article 7

International students applying for admission to a university or tertiary college shall submit the following documents and apply directly to the university or college during its designated application period, and applicants who pass the review or screening process will be issued an admission notice:

1. An enrollment application form

2. Academic credentials:

(1) Academic credentials from the Mainland Area: shall be handled in accordance with the provisions of the Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area.

(2) Academic credentials from Hong Kong or Macao: shall be handled in accordance with the provisions of the Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao.

(3) Academic credentials from other areas:

A. Academic credentials issued by an Overseas Taiwan School or a school for Taiwan business people in the Mainland Area shall be regarded as equivalent to academic credentials issued by an educational institution of the same level in Taiwan.

B. Academic credentials from overseas other than those referred to the preceding two items shall be handled in accordance with the provisions of the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education. However, academic credentials issued by a campus or branch that a foreign educational institution has established in the Mainland Area by a foreign educational institution shall be notarized by a notary public there and authenticated by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan.

3. Proof of applicant's having sufficient funds to live on while studying in Taiwan, or proof of having a full scholarship or grant provided by a government, university, college, or private organization.

4. Other documents required by the educational institution being applied to.

When an educational institution reviews an international student's admission application, if any of the documents specified in Subparagraphs 2 and 4 of the preceding paragraph have not been authenticated by an overseas mission, or by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan, and the educational institution has any doubts about them, it may request authentication by an overseas agency. If documents that have already been authenticated raise any doubts, the educational institution may request examination of the documents.

The admission notice referred to in Paragraph 1 shall set out in detail in both Chinese and English the name of the international student, the name of their program of study, the degree level, the language of instruction, the academic year of enrollment, the date the semester begins, the tuition and miscellaneous fee collection and refund criteria, any scholarship or grant awarded to the student, and any other pertinent information that international students must be notified of, and verify that international students studying in Taiwan understand their associated rights and obligations. A university or tertiary college institution may provide versions of these details in other mother languages of its international students.

Article 7-1

An international student who submits any certificate or document as part of their application for admission to an educational institution that is found to be forged, fabricated, or that has been altered in some way shall have their enrollment eligibility revoked. If the student has already registered and begun classes, their registration as a current student shall be cancelled and they will not be awarded any certification whatsoever regarding their related academic undertakings. If any such circumstances are first discovered after a student has already graduated, the educational institution shall revoke the former student's eligibility to graduate and shall require any degree already awarded to be returned and shall rescind it.

Article 8

An international student who has completed a bachelor's degree or a higher degree in Taiwan and is applying to be admitted to do a master's degree program or a higher degree may submit copies of their graduation certificate from the university or tertiary college in Taiwan and transcripts for each year of their studies and apply in accordance with the provisions of Article 7 and is, without having to submit the overseas academic records referred to in the provisions of Article 7, Paragraph 1, Subparagraph 2.

An international student who meets the criteria set out in Article 2, Paragraph 1, and who has completed an associate degree program or a program below that level in Taiwan, may submit copies of their graduation certificate and transcripts for each year and apply for admission to a bachelor's degree program or a lower level program in accordance with the provisions of Articles 7, 18, and 20, without having to submit the overseas

academic records referred to in the provisions of Article 7, Paragraph 1, Subparagraph 2; Article 18, Paragraph 1, Subparagraph 2; and Article 20, Paragraph 1, Subparagraph 3.

Article 9

A university or tertiary college that admits international students shall promptly register details of the following into the international student data management information system designated by the Ministry of Education: the international students admitted and registered, any transfer, deferral or abandonment of studies, any change to or loss of student status, and any departure from Taiwan.

Article 10

An international student is not permitted to apply to study any recurrent or continuing education bachelor's degree program or in-service master's degree program, or any other program which is only taught in the evening or during vacations, at a university or tertiary college in Taiwan. However, an international student who already has legitimate resident status or who is undertaking a program approved on a case by case basis by the Ministry of Education is not subject to this restriction.

Article 11

An international student who reports to register at a university or tertiary college, a five-year program at a junior college, or a senior secondary school, junior high school, or an elementary school before it is already one-third of the way into the first semester of the current academic year shall be registered for the first semester. If it is already more than one-third of the way into the first semester, the international student shall register for the second semester or the next academic year. However, this restriction does not apply if each competent education administrative authority has some provision that overrides it.

Article 12

An international student who with Ministry of Education approval is undertaking an internship after graduating from a university in Taiwan may have their international student status extended for up to one year after their graduation.

An international student who after coming to Taiwan to study has been permitted to undertake initial household registration, resident registration, naturalization, or restoration of R.O.C. nationality procedures during the course of their studies in Taiwan will forfeit their international student status and shall be dismissed by their educational institution. However, this does not apply to a person in any of the following circumstances:

1. The student's admission to their educational institution was handled in the same manner as for the admission of domestic students.
 2. The student applies for naturalization to acquire R.O.C. nationality in accordance with the provisions of Subparagraph 1 to Subparagraph 3, Paragraph 1, Article 4 of the Nationality Act.
 3. The student meets the criteria set out in the provisions of Article 2, Paragraph 1 and applies for naturalization to acquire R.O.C. nationality in accordance with the provisions of Article 3 to Article 7 of the Nationality Act.
- Each university or tertiary college shall formulate its own regulations governing transfers of international students who are studying at a university or tertiary college in Taiwan, incorporate these into its admission regulations, and submit these to the Ministry of Education for approval. However, an international student who has been dismissed by the educational institution that admitted that student as a result of unsatisfactory conduct or of a conviction in criminal case proceedings is not permitted to transfer to another university or tertiary college.

Article 13

A university or tertiary college may sign an education cooperation agreement with a foreign educational institution and recruit and admit international exchange students, provided that this does not affect normal teaching. A university or tertiary college may also apply, *mutatis mutandis*, its own international student admission regulations to accept suitable international students as non-degree students.

With approval from each competent education administrative authority, senior secondary schools, junior high schools, and elementary schools may recruit international students for short-term periods of study in Taiwan of one year or less.

Article 14

Educational institutions at all levels that establish programs exclusively for international students as part of an international academic cooperation program or to meet some other special need shall do so in accordance with the regulations governing overall scale of and resources for development of an educational institution at their level, and the competent education administrative authority will forward details of such programs for appraisal and approval by the Ministry of Education.

Article 15

In order to provide incentive awards for outstanding international students who are studying at universities and tertiary colleges in Taiwan, the Ministry of Education may set up international student scholarships or may subsidize universities and tertiary colleges to do so.

To encourage international students to come and study in Taiwan, universities and tertiary colleges may allocate funds to set up scholarships or financial study assistance to international students.

Article 16

Universities and tertiary colleges shall designate units or personnel to be responsible for handling international student admission applications, counselling, and liaison matters. These units or personnel shall also boost the arrangement of homestay accommodation for international students, and of assistance for them to learn Mandarin Chinese and about Taiwan culture in order to better enhance their understanding of Taiwan. At different times each academic year, universities and tertiary colleges shall organize counselling activities for international students or accelerate campus internationalization, to help to foster exchanges and interactions between local students and international students.

Article 17

A five-year program at a junior college, or a senior secondary school, junior high school, or an elementary school that admits international students shall, apart from complying with the provisions of Article 20 when handling applications from international students who have legitimate resident status in Taiwan, prepare an international student recruitment plan and submit the plan to the competent education administrative authority for approval no later than November 30 each year, before recruitment may begin. The competent education administrative authorities at the municipality, county, and city levels shall submit their approved lists of the approved quotas for each educational institution in their jurisdiction to the Ministry of Education no later than December 31 each year for future reference.

The plan referred to in the preceding paragraph shall include the establishment of a dedicated unit responsible for international students, planning to increase Chinese language and culture courses, and measures for arranging accommodation for international students.

When necessary, the categories of countries and quotas for the admission of international students referred to in Paragraph 1 may be stipulated by the Ministry of Education in consultation with the Ministry of the Interior, and the Ministry of Foreign Affairs.

Article 18

Unless otherwise specified in Article 20, an international student applying for admission to a five-year program at a junior college, or a senior secondary school, junior high school, or an elementary school shall directly apply to the junior college or school during its designated admission period and submit the following documents. If an applicant passes the review or screening process, the junior college or school will issue an admission notice.

1. An enrollment application form.

2. Academic credentials:

(1) Academic credentials from the Mainland Area: shall be handled in accordance with the provisions of the Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area.

(2) Academic credentials from Hong Kong or Macao: shall be handled in accordance with the provisions of the Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao.

(3) Academic credentials from other areas:

A. Academic credentials issued by an Overseas Taiwan School or a school for Taiwan business people in the Mainland Area shall be regarded as equivalent to academic credentials issued by an educational institution of the same level in Taiwan.

B. Academic credentials from overseas other than those referred to the preceding two items shall be handled in accordance with the relevant provisions of the applicable Ministry of Education regulations governing the assessment and recognition of international students' academic credentials and records. Academic credentials issued by a campus or branch of a foreign educational institution which it has established in the Mainland Area shall be notarized by a notary public office there and authenticated by an authority established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan.

3. Proof of applicant's having sufficient funds to live on while studying in Taiwan.

4. Documentary evidence of the eligibility of a guardian in Taiwan.

5. A power of attorney from the student's parents or other legal representative, which has been authenticated by an overseas mission, appointing the guardian in Taiwan.

6. A letter of agreement from the guardian in Taiwan which has been notarized by a notary public in Taiwan.

7. Any other documents required by the school, college, or university.

The academic credentials stipulated in Subparagraph 2 of the preceding paragraph are not required to be submitted for an application to be admitted for the first semester of the first grade of elementary school.

Adult international students are not required to submit the documents stipulated in Paragraph 1, Subparagraphs 4 to 6.

When a junior college, or school is reviewing an international student's admission application, if any of the documents specified in Paragraph 1, Subparagraphs 2, 3, and 7 have not been authenticated by an overseas mission, or by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan, and the junior college or school has any doubts about them, it may request authentication by an overseas agency. If documents that have already been authenticated raise any doubts, the junior college or school may request examination of the documents.

Article 19

The guardian in Taiwan referred to in the preceding article shall be an R.O.C. citizen who has household registration in Taiwan and shall submit a Police Criminal Record Certificate, and an income tax inventory for the most recent year checked and issued by a taxation organization itemizing personal taxable income from all sources of at least TWD 900,000.

A person who satisfies the requirements prescribed in the preceding paragraph may serve as the guardian in Taiwan of only one international student. However, a school principal, or the chair of the board of directors of an incorporated school or a board member may act as the guardian in Taiwan of up to five international students.

Article 20

An international student who has legitimate resident status in Taiwan and is applying to study a five-year program at a junior college, or at a senior secondary school, junior high school, or an elementary school shall submit the following documents and apply directly to the junior college or school, and report to register there if their application is approved:

1. An enrollment application form;

2. A photocopy of a legitimate resident permit;

3. Academic credentials:

(1) Academic credentials from the Mainland Area: shall be handled in accordance with the provisions of the Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area.

(2) Academic credentials from Hong Kong or Macao: shall be handled in accordance with the provisions of the Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao.

(3) Academic credentials from other areas:

A. Academic credentials issued by an Overseas Taiwan School or a school for Taiwan business people in the Mainland Area shall be regarded as equivalent to academic credentials issued by an educational institution of the same level in Taiwan.

B. Academic credentials from overseas other than those referred to the preceding two items shall be handled in accordance with the relevant provisions of the applicable Ministry of Education regulations governing the assessment and recognition of international students' academic credentials and records. Academic credentials issued by a campus or branch of a foreign educational institution which it has established in the Mainland Area shall be notarized by a notary public office there and authenticated by an authority established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan.

The academic credentials stipulated in Subparagraph 3 of the preceding paragraph are not required for an application for admission to the first semester of first grade at an elementary school.

When a junior college, or school is reviewing an international student's admission application, if any of the documents specified in Paragraph 1, Subparagraph 3 have not been authenticated by an overseas mission, or by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan, and the junior college or school has any doubts about them, it may request authentication by an overseas agency. If documents that have already been authenticated raise any doubts, the junior college or school may request examination of the documents.

After the admission of the international students referred to in Paragraph 1, a senior secondary school, junior high school, or an elementary school shall submit a list of their details to the competent education administrative authority for future reference.

If a senior secondary school, junior high school, or an elementary school cannot admit the international student referred to in Paragraph 1 applying to study there because the school has already filled its admission quota, the student may apply to the competent education administrative authority for a transfer to be admitted to a school that has a vacancy.

A senior secondary school, junior high school, or an elementary school may assign the international student referred to in Paragraph 1 applying to study there to an appropriate grade level or give them a 'provisional' admission status, based on their results during the screening process. This 'provisional' status is valid for up to one year, and their student registration shall be confirmed if they pass the examinations.

Article 20-1

If a chaotic war situation, major disaster, or major epidemic occurs in the country of an international student, and educational institutions in the region become unable to operate normally as a result, that student's admission to senior secondary school or junior college may be given special consideration on a case by case basis, if details of those circumstances have been assessed and submitted by an R.O.C. overseas mission or by the embassy, consular office or authorized representative office of the student's country in Taiwan, and then confirmed by the Ministry of Education in conjunction with the Ministry of Foreign Affairs, and the National Immigration Agency of the Ministry of the Interior.

In principle, the additional student admission quota referred to in the previous paragraph for students given special consideration on a case by case basis shall be one percent of the total student recruitment quota approved for that school or junior college.

Article 21

The tuition related fees that international students in Taiwan shall pay are determined as stipulated below:

1. Students who have been admitted to study in Taiwan in accordance with the provisions of the previous two articles, or who have received a MOFA Taiwan Scholarship following recommendation by an overseas mission, or who have the status of permanent residents in Taiwan shall pay tuition and other fees in accordance with the standard fees that their educational institution applies to domestic students.
2. Students admitted to an educational institution in Taiwan in accordance with an education cooperation agreement shall pay their tuition and other fees as specified in the agreement.
3. If an international student is not covered by the provisions of either of the preceding two subparagraphs, an educational institution may charge the student based on the standard tuition and other fees for international students that it has determined, and these are not permitted to be lower than the fees levied by other private educational institutions at the same level.

A student who was admitted to an educational institution in Taiwan before the date of effect of the February 1, 2011 amendment to these Regulations shall pay tuition and other for this stage of education fees in accordance with the pre-amendment provisions.

Article 22

When a new international student registers, they shall submit proof of being covered by a medical and injury insurance policy which is valid for at least six months from the date that they entered Taiwan. Current students shall present documentary proof that they have joined Taiwan's National Health Insurance Plan. If the proof of insurance referred to in the previous paragraph was issued in a foreign country it shall be authenticated by an overseas mission.

Article 23

If an investigation verifies that an international student has violated the provisions of the Employment Services Act, their educational institution, or the appropriate competent authority shall immediately handle the matter in accordance with the regulations.

Article 24

If an international student defers or abandons their studies, or if there is any change to or loss of their student status, their educational institution shall notify the Bureau of Consular Affairs of the Ministry of the Foreign Affairs, the service center(s) of the National Immigration Agency of the Ministry of the Interior where their educational institution is located, and send copies of these notifications to the Ministry of Education.

Article 25

If any educational is found to be in violation of any of the provisions of these Regulations, the competent education administrative authority shall deal with that educational institution in accordance with the provisions of the applicable ordinances.

If an educational institution is not acting in accordance with the provisions of Article 23, depending on the circumstances, the appropriate competent education administration authority may also adjust the international student enrollment quotas for that educational institution.

Article 26

The provisions of Article 7, Paragraph 4, Subparagraphs 1, 3, and 4, and of Articles 9, 15, 16, 22, and 24 also apply, *mutatis mutandis*, to the application procedures, scholarships and subsidies, supervision and guidance, absences from one quarter or more of the total scheduled class hours of a semester, and the reporting of changes to or loss of student status for international students who come to Taiwan to study Mandarin at a Chinese Language Centers affiliated with a university or tertiary college in Taiwan.

Article 27

The format of the forms referred to in Article 7, Paragraph 1, Subparagraph 1; in Article 18, Paragraph 1, Subparagraph 1; and in Article 20, Paragraph 1, Subparagraph 1 shall be determined by each educational institution. The format of the forms referred to in Article 18, Paragraph 1, Subparagraphs 5 and 6 shall be prescribed by the Ministry of Education.

Article 27-1 Experimental education institutes may recruit international students to study in Taiwan in accordance with the Enforcement Act for Non-school-based Experimental Education at Senior High School Level or Below, and apply, *mutatis mutandis*, the provisions of the following articles of these Regulations:

1. Article 2.
2. Article 3.
3. Article 4.
4. Article 11.
5. Article 13, Paragraph 2.
6. Article 17, Paragraph 1.
7. Article 18.
8. Article 19, Paragraph 1.
9. Article 20, Paragraph 1 to Paragraph 4.
10. Article 22.
11. Article 23.

12. Article 25, Paragraph 1.

13. The preceding article.

The plans that an experimental education institute draws up related to international students' undertaking studies at their institute in Taiwan shall include items pertaining to putting in place personnel specifically responsible for international students.

The categories of countries from which an experimental education institute is permitted to recruit international students are the same as those set out in the regulations specifying the categories of countries from which elementary and secondary level schools are permitted to recruit international students.

A person who meets the criteria set out in Article 19, Paragraph 1 is restricted to being the guardian of just one international student. However, any person who is also the person in charge of an experimental education institute or is the legal representative of a non-profit body that has established an experimental education institute, that person is restricted to being the guardian of up to five international students.

Experimental education institutes shall incorporate the regulations they draw up governing the fees for international student that they enroll and associated refunds into the fee collection and refund regulations referred to in Article 6, Paragraph 4, Subparagraph 7, of the Enforcement Act for Non-school-based Experimental Education at Senior High School Level or Below.

If an international student loses their student status, suspends their studies, or changes or terminates their undertaking a period of short-term study, or had other changes in their circumstances, the experimental education institute shall notify the Bureau of Consular Affairs of the Ministry of the Foreign Affairs, the service center(s) of the National Immigration Agency of the Ministry of the Interior where the experimental education institute that the student attended is located, and send copies of these notifications to the Ministry of Education, and to the competent education administrative authority of the special municipality, county or city where the experimental education institute that the student attended is located, and the school where the student is nominally registered.

Article 28

These Regulations shall take effect on August 1, 2012.

The amendments to these Regulations shall take effect on the date of promulgation, with the exception of the amendments promulgated on December 24, 2012 which shall take effect on January 1, 2013, and the amendments promulgated on August 23, 2013 which shall take effect on September 1, 2013.

教育部 大學辦理國外學歷採認辦法

第 1 條

本辦法依大學法第二十八條第二項規定訂定之。

第 2 條

大學辦理持國外學歷入學學生之學歷採認事宜，應依本辦法規定為之。

第 3 條

本辦法用詞，定義如下：

- 一、採認：指受理學校就申請人所檢附之國外學歷文件所為與國內同級同類學校相當學歷之認定。
- 二、參考名冊：指教育部（以下簡稱本部）就外國大專校院，收錄其名稱、地址所彙集而成並經公告之名冊。
- 三、驗證：指申請人持國外學校學位證書、成績證明等證件，向我國駐外使領館、代表處、辦事處或其他經外交部授權機構（以下簡稱駐外館處）申請證明文件為真。
- 四、查證：指學校查明證實當地國政府學校權責機關或其認定之教育專業評鑑團體對學校認可情形與其入學資格、修業期限及修習課程等事項。

第 4 條

國外學歷符合下列各款規定者，始得採認：

- 一、畢（肄）業學校應為已列入參考名冊者；未列入參考名冊者，應為當地國政府學校權責機關或其認定之教育專業評鑑團體所認可。
- 二、修業期限、修習課程，應與國內同級同類學校規定相當。

第 5 條

申請人申請國外學歷採認，應自行檢具下列文件，送各校辦理：

- 一、國外學歷證件及歷年成績證明影本一份。
- 二、包括國外學歷修業起迄期間之入出國主管機關核發之入出國紀錄一份。但申請人係外國人或僑民者，免附。
- 三、其他學校規定之相關文件。

前項第一款文件，受理學校得逕向申請人國外畢業學校查證、函請我國駐外館處協助查證，或請申請人辦理驗證。

第六條第八項及第九項之申請人，得以經當地國政府學校權責機關或其認定之教育專業評鑑團體出具之證明文件代替第一項第二款資料。

第 6 條

第四條第二款所稱修業期限，指申請人停留於當地學校之修業時間，其規定如下：

- 一、持高級中等學校學歷者，累計修業時間應符合當地國學制之規定。
- 二、持學士學位者，累計修業時間至少須滿三十二個月。
- 三、持碩士學位者，累計修業時間至少須滿八個月。
- 四、持博士學位者，累計修業時間至少須滿十六個月。
- 五、碩士、博士學位同時於同校系（所）修習者，累計修業時間至少須滿二十四個月。
- 六、以專科學校畢業學歷或具專科學校畢業同等學力進修學士學位者，累計修業時間至少須滿十六個月。

前項修業期限，各校應對照國內外學制情形，以申請人所持國外學歷當地國學制、修業期間學校行事曆及入出國紀錄等綜合判斷，其所停留期間非屬學校正規學制及行事曆所示修課時間者，不予採計。修讀學士學位表現優異者，其修業期限，得由各校衡酌各該國外大學學制規定及實際情況，予以酌減。

符合特殊教育法所稱身心障礙者，其修業期限，得由各校衡酌各該國外大學學制、身心障礙程度及其他實際情況，予以酌減。

經由國際學術合作模式，同時在國內外大學修讀同級學位者，不得全程於國內大學修業；其修業期限，得累計其停留於各當地大學之修業時間，並應符合下列規定，不適用第一項規定：

- 一、持學士學位者，累計修業時間至少須滿三十二個月。
- 二、持碩士學位者，累計修業時間至少須滿十二個月。
- 三、持博士學位者，累計修業時間至少須滿二十四個月。

前項申請人於國內外大學修習之學分數，累計應各達獲頒學位所需總學分數之三分之一以上。

申請人修業時間達第一項或第五項所定修業期限三分之二以上，其修業期限得由學校就申請人所持國外學歷當地國學制、修業期間學校行事曆、入出國紀錄及國內同級同類學校學制等綜合判斷是否符合大學入學同等學力後予以採認。

申請人入學所持國外學歷依國外學校規定須跨國（不包括我國）修習者，由申請人出具國外學校證明文件並經學校查證認定後，其跨國之修業期限得併計為第一項所定之當地修業期限，且該跨國修習學校應符合第四條、大陸地區學歷採認辦法或香港澳門學歷檢覈及採認辦法之規定。

申請人持國內大學與國外大學合作設立經本部專案核定之學位專班學歷入學者，其停留國內大學之修業期限得併計為第一項及第五項所定之修業期限。

第 7 條

第四條第二款所定修習課程，如以遠距教學方式修習，取得國外學校學歷者，應在符合第四條第一款規定之學校修習科目學分，或經由國際學術合作在國內大學修習學分，其學分數並符合國內遠距教學之規定。

第 8 條

各校辦理國外學歷採認，除藝術類文憑，應依本辦法規定辦理查證後採認外，應依下列程序為之：

- 一、國外高級中等學校學歷或已列入參考名冊之國外學校學歷，由各校依本辦法規定採認。

二、未列入參考名冊之國外學校學歷，各校應依本辦法規定辦理查證後採認。

前項採認如有疑義時，學校應組成學歷採認審議小組進行採認；該小組之組織及運作規定，由學校定之。

經前項學校審議小組審議後仍無法逕行採認者，學校得敘明疑義，並檢附相關證明文件送本部協助。

第 9 條

各校辦理國外學歷查證，應由申請人出具授權查證之同意書及相關文件。

各校向申請人國外畢業學校查證，或函請駐外館處協助查證申請人所持國外學歷之項目如下：

- 一、入學資格。
- 二、修業期限。
- 三、修習課程。
- 四、當地國政府學校權責機關或其認定之教育專業評鑑團體對學校認可情形。
- 五、其他必要查證事項。

第 10 條

國外學歷有下列情形之一者，不予採認：

- 一、經函授方式取得。
- 二、各類研習班所取得之修課證書（明）。
- 三、取得博士學位候選人資格未獲得博士學位，申請採認相當於碩士學位資格。
- 四、未經註冊入學及修業，僅以論文著作取得博士學位。
- 五、名（榮）譽學位。
- 六、非使用中文之國家或地區，以中文授課所頒授之學歷。但不包括高級中等學校學歷。
- 七、未經本部核定，在我國所設分校、分部及學位專班，或以國外學校名義委託機構在國內招生授課取得之學歷。
- 八、以遠距教學方式取得之學歷不符第七條規定者。

第 11 條

申請人所提供之各項證件，有偽造、變造、冒用等不實情事，經調查屬實者，應予撤銷其學歷之採認。獲錄取者，撤銷其入學許可；已註冊入學者，撤銷其學籍，且不發給與修業有關之任何證明文件；畢業後發現者，撤銷畢業資格，並請申請人繳還及註銷學位證書；涉及刑事責任者，移送檢察機關依法辦理。

第 12 條

國內各用人或考試機構採認國外學歷者，得由各該主管機關參照本辦法規定辦理。

第 13 條

本辦法自發布日施行。

Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education

Article 1

These Regulations have been formulated in accordance with Article 28, Paragraph 2 of the University Act.

Article 2

Institutions of higher education shall undertake the assessment and recognition of foreign academic records of students applying for admission, in accordance with the provisions of these Regulations.

Article 3

Terms used in these Regulations are defined as follows:

1. Assessment and recognition: refers to the determination by the institution of higher education handling an application whether the foreign academic credentials and documentary records submitted by an applicant are equivalent to those issued by an educational institution in Taiwan of an equivalent academic level and nature.
2. Reference list: refers to the list of the names and addresses of foreign tertiary level institutions of higher education recognized by the Ministry of Education, put together and made public by the Ministry of Education.
3. Authentication: refers to an applicant submitting documents such as a degree or transcripts from a foreign educational institution to an ROC embassy, consulate, representative office, or office, or other agency authorized by the Ministry of Foreign Affairs (hereunder referred to as “an overseas mission”) and applying to have the documents certified as authentic.
4. Verification: refers to an institution of higher education checking the nature of the approval that a foreign educational institution has actually been given by the government authority responsible for such educational institutions or by the professional accreditation agency for education in the country where it is located, and its admission requirements, the restrictions on the period spent undertaking a program, and the courses that must be completed.

Article 4

Only foreign academic records that satisfy each of the following provisions may be assessed for recognition:

1. The educational institution from which the applicant graduated or where they have been studying but have not yet graduated shall already be listed in the reference list. An educational institution not in the reference list shall have been accredited by the government authority responsible for such educational institutions or by the professional accreditation agency for education in the country where it is located.
2. The restrictions on the period spent undertaking a program, and the courses that must be completed shall be comparable to those prescribed for a comparable program at an educational institution in Taiwan of an equivalent academic level and nature.

Article 5

An applicant applying for assessment and recognition of their foreign academic credentials shall personally submit the following documents to each institution of higher education that they are applying to for admission:

1. A photocopy of their foreign academic credentials and of transcripts for each year of their studies
2. A record of the applicant’s cross-border entries and exits, issued by the competent entry and exit authority, that covers the full period of their studies for their foreign academic credential. However, an applicant who is a foreign citizen or an overseas compatriot is not required to include this.
3. Other relevant documents specified by the institution of higher education.

The institution of higher education handling the application may deal with the documents referred to in Subparagraph 1 of the preceding paragraph by requesting the foreign educational institution from which the

applicant graduated to verify the documents, by writing to an ROC overseas mission and requesting its assistance to undertake verification, or by asking the applicant to arrange to have the documents authenticated.

The applicant referred to in Article 6, Paragraph 8 and Paragraph 9 may submit documentary evidence issued by the government authority responsible for such educational institutions or by the accreditation agency for education in the country where the foreign educational institution is located, in place of the record referred to in Paragraph 1, Subparagraph 2.

Article 6

The “restrictions on the period spent undertaking a program” in Article 4, Subparagraph 2 refers to the period that the applicant spent undertaking a program at a foreign educational institution and the following provisions apply:

1. An applicant who has senior secondary school academic credential shall have spent a total period undertaking the senior secondary program that satisfies the regulations of the education system in the country where the school they attended is located.
2. An applicant who has a bachelor’s degree shall have spent a total period of at least 32 full months undertaking the bachelor’s degree program.
3. An applicant who has a master’s degree shall have spent a total period of at least eight full months undertaking the master’s degree program.
4. An applicant who has a doctorate shall have spent a total period of at least 16 full months undertaking the doctorate program.
5. An applicant who concurrently completed the programs for and obtained both a master’s degree and a doctorate at the same university (graduate institute) shall have spent a total period of at least 24 full months undertaking the master’s degree and doctorate programs.
6. An applicant who has an academic credential after graduating from a junior college or who has an associate’s degree and academic ability equivalent to having graduated from a junior college shall have spent a total period of at least 16 full months undertaking the associated program.

With regard to the restrictions on the period spent undertaking a program referred to in the preceding paragraph, each institution of higher education shall compare the domestic and foreign education systems at that level and make an overall determination taking into account the education system in the country where the applicant obtained the foreign academic credential, the administrative calendar of the educational institution during the period the applicant was undertaking the program, and the applicant’s cross-border entry and exit record. If a period that the applicant spent in that foreign locality is not consistent with the regular length of a program at that educational institution or the program schedule indicated on its administrative calendar, that period will not be counted.

If an applicant had an outstanding performance during their study for a bachelor’s degree, the educational institution to which they are applying may make a discretionary reduction to the required period spent undertaking their bachelor’s degree program, taking into due consideration the regulations governing the length of programs at institutions of higher education in that particular foreign country, and the specific circumstances.

If a person is categorized as having a physical or mental disability as defined in the Special Education Act, the educational institution to which they are applying may make a discretionary reduction to the required time which they spent undertaking their program, taking into due consideration the length of programs at institutions of higher education in that particular foreign country, the extent of their physical and/or mental disability, and other specific circumstances.

If an applicant undertook a degree program that can be taken concurrently at the same level at a domestic institution of higher education and a foreign one under an international academic collaboration program, the applicant is not permitted to have completed the program entirely at the domestic institution. The total time the applicant spent undertaking the degree program at each of the institutions of higher education may be combined; it shall be subject to the following provisions, and the provisions of Paragraph 1 are not applicable:

1. An applicant who has a bachelor's degree shall have spent a total period of at least 32 full months undertaking the bachelor's degree program.
2. An applicant who has a master's degree shall have spent a total period of at least 12 full months undertaking the master's degree program.
3. An applicant who has a doctorate shall have spent a total period of at least 24 full months undertaking the doctorate program.

The course credits earned by an applicant studying at the domestic institution of higher education and those earned at the foreign institution of higher education referred to in the preceding paragraph shall in each case be at least one-third of the total number of course credits required by each of the institutions for the conferral of such a degree.

If the period that the applicant spent undertaking their program is at least two-thirds of the requirement stipulated in Paragraph 1 or in Paragraph 5, the institution of higher education may assess their foreign academic credential for recognition, after first making an overall determination of whether the applicant's educational level is equivalent to that required for admission to an institution of higher education, taking into account the education system in the country where the applicant obtained their foreign credential, the administrative calendar of the educational institution during the period the applicant was undertaking the program, the applicant's cross-border entry and exit record, and the length of programs at a domestic educational institution of an equivalent academic level and nature.

If an applicant for admission to a university has been awarded a foreign academic credential that, in accordance with the regulations of the foreign university, required courses to be undertaken abroad (including in the Mainland Area, Hong Kong, and Macao, but not including Taiwan), the period that the applicant spent undertaking courses abroad may be included when calculating whether they satisfy the requirement stipulated in Paragraph 1 if the applicant has submitted documentary evidence from the foreign university and the domestic university has undertaken verification and given approval. In addition, any educational institution(s) at which the courses abroad were undertaken shall satisfy the provisions of Article 4, the provisions of the Regulations Governing the Assessment and Recognition of Educational Qualifications from the Mainland Area, or the provisions of the Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao.

If an applicant being admitted has an academic credential obtained after undertaking a professional degree program offered by a collaborating domestic university and a foreign university that was approved by the Ministry of Education on a case by case basis, when calculating whether they satisfy the requirements stipulated in Paragraph 1 and in Paragraph 5, the period that they spent undertaking courses at the domestic university may also be included.

Article 7

With regard to the courses that must be completed referred to in Article 4, Subparagraph 2, if the academic credential conferred by a foreign educational institution is obtained by completing courses in distance learning mode, the course credits earned shall have been taken at an educational institution that satisfies the provisions of Article 4, Subparagraph 1 or with a domestic university under an international academic collaboration program. The number of credits shall also satisfy the regulations governing domestic distance education.

Article 8

Each university shall follow the procedure set out below when undertaking the assessment and recognition of all foreign academic credentials except arts related diplomas. Arts related diplomas shall first be verified in accordance with the provisions of these Regulations and then be assessed and recognized:

1. The assessment and recognition of academic records issued by a foreign senior secondary school, or of academic credentials issued by a foreign educational institution on the reference list, shall be carried out by the university in accordance with the provisions of these Regulations.
2. Academic credentials issued by a foreign educational institution that is not on the reference list shall first be verified by the university in accordance with the provisions of these Regulations and then be assessed and

recognized.

If any doubt arises during the assessment and recognition referred to in the previous paragraph, the university shall organize an academic credential assessment and recognition review panel to undertake the assessment and recognition. The university shall stipulate the regulations governing the organization and operations of the panel.

If the university's review panel referred to in the previous paragraph is still unable to undertake the assessment and recognition, the university may submit an explanation of the matter raising doubt to the Ministry of Education, together with related documentary evidence, and request its assistance.

Article 9

When undertaking verification of foreign academic credentials, each university shall require the applicant to submit a letter of consent authorizing it to undertake verification, and related documents.

The university may ask the foreign educational institution from which an applicant graduated to verify the following matters regarding the applicant's foreign academic credential(s), or send a written request to an overseas mission for assistance to do so:

1. Admission requirements;
2. The restrictions on the period spent undertaking a program;
3. The courses that must be completed;
4. The nature of the approval given to the educational institution by the government authority responsible for such educational institutions or by the professional accreditation agency for education in the country where it is located;
5. Any other matters that require verification.

Article 10

The following academic credentials awarded in a foreign country are not eligible for assessment and recognition:

1. An academic credential obtained by completing a program in correspondence mode.
2. Certificates awarded after undertaking attendance at any kind of training courses, seminars, or workshop.
3. Having obtained candidate status for a doctorate without having been awarded the doctorate. A person with this status may apply for assessment and recognition as having the equivalent of a master's degree.
4. A doctorate conferred only on the basis of having completed a dissertation, without having registered, been admitted, and undertaking any courses.
5. Honorary degrees.
6. An academic credential awarded for a program undertaken in a non-Chinese speaking country or region, with Chinese as the language of instruction. This, however, does not include any senior secondary academic credential.
7. An academic credential obtained from a foreign educational institution that has established a branch or a division and professional degree programs in Taiwan that do not have Ministry of Education approval, or obtained from an institution commissioned to recruit students and teach courses in Taiwan in the name of a foreign educational institution without Ministry of Education approval.
8. Any academic credential obtained in distance learning mode which does not satisfy the provisions of Article 7.

Article 11

If any documents provided by an applicant are found to not be genuine by being forged or altered in any way, or by presenting another person's details as the applicant's own, after this has been investigated and confirmed, the assessment and recognition of the applicant's academic credential(s) shall be revoked. A student who has already been admitted will have their permission to enroll as a student revoked. If a student has already registered and begun classes, their registration as a current student shall be cancelled and they will not be

awarded any documentary certification whatsoever regarding their related academic undertakings. If any such circumstances are first discovered after a student has already graduated, the educational institution shall revoke the former student's eligibility to graduate and shall request the applicant to return any degree already awarded and shall rescind it. If any such circumstances involve any criminal liability, the matter shall be referred to a prosecutorial authority to handle in accordance with the law.

Article 12

The competent authority of any domestic employment or examination agency which assesses and recognizes foreign academic credentials may consult the provisions of these Regulations for reference.

Article 13

These Regulations shall come into effect on the date of promulgation.
